RECORDS/ROADS Paul Rogan 1 RTK; patching will be starting. Rosenstock read the following: "At the August meeting, when I addressed concerns that the roads were not being repaired properly, and, in effect, could be a waste of \$22,000, I was told by Rogan that we were doing what the Borough could afford. I then inquired about the \$60,000.00 plus in discretionary funds (his words) he wanted to the Basler family for land at Penn Lake. My concern was that his money would be better spent towards proper road repair. He replied that the discretionary funds were used for the police patrolling Penn Lake. I want to state here that, in the 2015 budget approved by this council, the police are, in truth, a line item budget item, not as part of the carryover funds from 2014 of \$78,000.00. The carryover funds are what Rogan refers to as discretionary. I also want to ask Rogan did you not intend to offer the Basler's \$60,000.00 of Borough funds for some of their land? I also want this as written to go into the September meeting, the secretary has complied.

MAYOR- No report

**DAM -Rob Johnson-** Addressed Dam inspection report from DEP since only one bid has come in and we are under a time constraint he asked for a motion to move forward. A **Motion** was made by Rogan and 2<sup>nd</sup> By Kuter to hire Bulls Eye to perform the work at a cost not to exceed \$1,820.00 and upon insurance approval from DGK, Roll Call: Rogan, aye, Kuter, aye, Johnson, abstain, Rosenstock, nay. Motion carried. Johnson will call Borton Lawson and will be meeting in the near future with DEP to discuss work at Dam.

RECREATION/SEWER Paul Rogan - No report

A **Motion** to appoint Shaun Kuter as Vice President of Council was made by Rogan and 2<sup>nd</sup> by Johnson. Roll Call: Rogan, aye, Johnson, aye, Kuter, abstain, Rosenstock, aye, Campbell, aye. 4 ayes, 1 abstain, motion carried.

A Motion to amend Ordinance #3, 1977 to reduce the number of members on the Planning Commission from 5 to 3 was made by Rogan and 2<sup>nd</sup> by Johnson. A discussion and public input was accepted at this time. Several felt the commission should stay at 5 stating the willingness of present members to continue. Barbara Sudimak began reading a prepared statement as to her credentials and reasons why the reduction should not take place. Roll call: Rogan, aye, Johnson, aye, Kuter, aye, Campbell, abstain, Rosenstock, nay. 3 ayes, 1 abstain, 1 nay, motion carried. Josephine Amoroso pleaded with the entire group to try to work together instead of against each other, while her time is limited she wishes from her heart that Penn Lake stay the close community it always has been.
