A **Motion** was made by Rogan and 2nd by Kuter to reimburse the liquid fuels account \$6,500.00 as mandated by the state. Roll call: Rogan, aye, Kuter, aye, Campbell, aye, Rosenstock, aye, all ayes, motion carried.

MAYOR- No report

DAM -Rob Johnson- in the absence of Mr. Johnson, President Rogan gave an overview of inspection and Mr. Smith's letter. Long term repairs and monitoring will be addressed as soon as DEP is allowed to travel which cannot happen until a state budget is passed.

RECREATION/SEWER Paul Rogan - No report

UNFINISHED BUSINESS:

Two garbage bids were received and open by Attorney Galante and rendered in compliance with bid package. They are as follows:

County Waste: 1 year \$40,260.00, 2nd year \$40,260.00, 3rd year \$41,280.00 J. P. Mascaro: 1 year \$45,096.00, 2nd year \$46,500.00, 3rd year \$47,880.00

Discussion ensued on the wisdom of continuing with County or taking the increase a **Motion** was made by Kuter and 2nd by Rogan to enter into a 3 year contract with County Waste at \$40,260.00 for year 1 & 2 and \$41,280.00 for year 3. Roll call: Rogan, aye, Kuter, aye, Campbell, aye, Rosenstock, nay, 3 ayes, 1 nay, motion carried.

At this point Rosenstock read a prepared statement and requested the secretary to include in minutes, secretary has complied. Rosentstock read

"As a Council member, I want this to go into this month's meeting minutes. December 2015 in response to Rogan's comments in the November minutes: 1. I, along with a previous council and the borough engineer, actively worked in 2012 and 2013 to repair the roads and find funding. As we learned, Lakeview had been paved of course decades ago, but never addressed correctly with under drain and base repair. With grants, we were able to repaid and repave Darby as well as the parking lots of this building and the recreation area. Due to the issue of no drainage existing for most of our roads, pothole patching in itself is a band aid and not the solution. I never said we should not repair the roads, nor fill the potholes, not ever. What was said was the money should go towards repairing the roads the correct way, to last the long haul and not just a season or 2.

- 2. Rogan knows, as well as does most of this Council, that he did intend to offer a private landowner here \$60,000.00 or borough "discretionary funds". My argument all along has been that any discretionary income would be better spent on proper road repair and far more pressing issues.
- 3. In November, as you can hear on the audio from the borough meeting minutes, Rogan calls the White Haven Police Department a political football. He also stated that they are funded from discretionary income. For several years now, the police have been a line item included in the budget. They also are no football, and I am embarrassed to have him belittle the value of the police coverage by referring to them as that. The comment political football insinuated that the WHPD do not serve our community in a positive way, and it disregards what most residents want. It is the responsibility of Council to keep this community safe. Contracting with the WHPD achieves that.

Also, not mentioned in the minutes were 2 grant opportunities available SHOULD the dam need "several tens of thousands of dollars in repair" For the record, they are grants that, with a 30% match, would cover 70% of the funding. They are the Commonwealth Financing Grant and PennDot Multi Modal.

The Council I had been so grateful to be part of from 2008 to 2013 received over \$100,000.00 in grants to pave some roads and other areas, restore the main beach, winterize this building including the purchase of a generator, repair all the damage brought from Tropical Storm Irene, and write a Comprehensive Plan. Without raising taxes we entered into a regional police department, brought in the UCC, we build a playground, bought a dock, fixed roads, held

community events like summer fun days for our children, and took down problem trees for residents, etc. This Council did away with the UCC, dismantled the Zoning Hearing Board and Planning Commission, and have reduced by also half the police coverage hours. And now they want to raise taxes.

Let me close by saying I value immeasurably my time on Council. I am so proud of what the previous council has accomplished...thing that hopefully will stand a long time after we are all gone. I am embarrassed and I apologize for having been a part of this one, however, Thank you. The 2016 budget was discussed the increase of .2 mills that would directly be put into a Dam account. A **Motion** was made by Rogan and 2nd by Kuter to adopt the 2016 Budget with a .6 mill tax base. Roll call: Rogan, aye, Kuter, aye, Campbell, aye, Rosenstock, nay, all ayes, motion carried.

NEW BUSINESS:

A **Motion** was made by Rogan and 2nd by Kuter to appoint Beverly Yencha as tax collector for the next two years. Roll call: Rogan, aye, Kuter, aye, Campbell, aye, Rosenstock, aye, all ayes, motion carried.

A **Motion** to pass **Resolution** #1 of 2015 the Luzerne County Hazard Mitigation Plan Update was made by Rogan and 2nd by Kuter. Roll call: Rogan, aye, Kuter, aye, Campbell, aye, Rosenstock, aye, all ayes, motion carried.

A **Motion** to pass **Resolution** #2 of 2015 setting the 2016 garbage fee at \$175.00, due by February 29, 2016 a \$25.00 fee added after that date was made by Kuter and 2nd by Campbell. Roll call: Rogan, aye, Kuter, aye, Campbell, aye, Rosenstock, aye, all ayes, motion carried. A **Motion** was made by Rogan and 2nd by Kuter to advertise the .6 mill tax ordinance for 2016 for adoption in January. Roll call: Rogan, aye, Kuter, aye, Campbell, aye, Rosenstock, nay, 3 ayes, 1 nay, motion carried.

A **Motion** was made by Rogan and 2nd by Kuter to advertise to set meeting dates as the second Thursday of the month with the exception of December 2016 which will be the third Thursday, work session to begin at 7 with meeting immediately following. Roll call: Rogan, aye, Kuter, aye, Campbell, aye, Rosenstock, aye, all ayes, motion carried.

A Motion was made by Kuter and 2nd by Rogan to un censor the Mayor, Tim Lenahan and thanked him for his service.

PUBLIC COMMENT:

Topics of discussion were but not limited to:

The playground equipment had there been any news, and why people would be willing to pay \$20.00 more in garbage fees but not in taxes to secure the lake.

A Motion to adjourn was made by Kuter and 2nd by Rogan all in favor, all ayes

The next meeting will be on January 12, 2016 at 7 p.m.
