## **APRIL 12, 2017**

The Penn Lake Park Borough April Council Meeting was held on 04/12/2017 in the Penn Lake Community House. President Paul Rogan called the meeting to order at 7:00 p.m. and opened with the Pledge of Allegiance to the Flag.

It was stated that the record should note the secretary and others were recording the meeting.

Roll Call: Paul Rogan, Vince Kimsal, Jasin Marth, Rich Campbell, all present, Shawn Kuter, absent, Mayor Deb Krysicki, present.

MINUTES A Motion was made by Rogan and 2<sup>nd</sup> Kimsal the March 9, 2017 minutes. All in favor: Rogan, aye, Campbell, aye, Kimsal, aye, Marth, aye, all ayes, motion carried. **TREASURERS REPORT** A Motion was made by Rogan and 2<sup>nd</sup> by Marth to accept April 12, 2017 treasurers report.

Roll call: Rogan, aye, Campbell, aye, Kimsal, aye, Marth, aye, all ayes, motion carried. **RECEIPTS/BILLS:** A **Motion** was made by Marth and 2<sup>nd</sup> by Rogan to pay bills of \$22,581.12 and accept receipts of \$59,169.99.

Roll call: Rogan, aye, Campbell, aye, Kimsal, aye, Marth, aye, all ayes, motion carried

**Petitions or complaints:** No written complaints although secretary noted that there had been a flurry on social media with regard to the snow fall received in March. The claim was that the Borough was not answering the phone and residents had some complaints about the roads. The secretary explained that she had no knowledge that the line was out of order until a councilman called her cell. She apologized on the social media and posted her cell number. Verizon has since fixed the line.

#### **CORRESPONDENCE:**

Letter from Penn Lake Association stating they had changed the locks on the building and needed a list from the Borough of all dates the building would be needed by the Borough, Planning Commission and Zoning Hearing Board. The reason was stated was vandalism and theft. The association will unlock and lock the building after said meetings. The secretary stated that since she and the President of Council were the only two to her knowledge that had keys, she wanted it to be a matter of record she had no knowledge of vandalism and that she did not take the toilet paper and trash bags that were missing last year.

The secretary of the Association stated they needed these dates to avoid any conflict with their events. The secretary of the Borough said she fully understood that and while she could provide Borough meeting dates the others would be more difficult as they are only scheduled as needed, so she does not always have a lot of advance notice.

# **COMMITTEE REPORTS:**

**POLICE-** 48 hours 3 calls of service

**MAYOR-Deb Krysicki-** All the Lakeview street signs have been adopted. If anyone else is interested in adopting a sign we will move onto secondary roads. An explanation was given on how to control the geese population by oiling the eggs, but since nesting takes place in March, April and May it was suggested we try to target next year. All proper procedures would be followed on whether they were mature or not. You may at any time dismantle the nest there are

no regulations on that procedure. The Mayor also addressed the police issue once again stating the original contract we were paying the police \$1,250/monthly \$15,000/yearly 7 hours of patrol in 2010; with the amended contract, we are paying \$833/monthly \$10,000/yearly 4.3 hours of patrol which is 1/3 hours of service. Reports have been reviewed and there is absolutely no increase of criminal activity and the system that we have in place is working. If you need the police you may dial 911 24/7 and will get a response. The Mayor stated that Chief has been nothing but respectful to her and has always come when she has called him.

LAKE MANAGEMENT/RECREATION Shaun Kuter —absent Kimsal noted that the fencing placed last year at the ball park was broken and falling over and will need to be addressed. ROADS-Vince Kimsal- the LSA (gaming grant) was denied for this year. So, any major paving project will have to be place on hold until next when we can apply again. We will continue to look for other grants. The tree trimmers will be here to take care of designated areas of concern. DAM — Paul Rogan-still waiting on GOE for photographs who claim they will be here in April on short notice, a new piezometer was ordered at a cost of \$396.31 below the \$500.00 allotted. SEWER: Paul Rogan —the recently setup system with Aqua is working, they called Borough before doing a repair. President Rogan then commented on a statement made by a resident during last month's public comment. At that time, the resident stated he would not pay his sewer availability fee since the prior owner had not paid theirs. Research was done and it was determined that the prior owners had indeed paid their fees and were not in arrears.

RTK/RECORDS: Rich Campbell -no report

#### **UNFINISHED BUSINESS:**

President Rogan and Councilman Kimsal both looked in getting the Ball Park surveyed. This is not a simple project and could be costly.

The PennVest loan was discussed again, and no action will be taken at this time including but not limited to paydown, reimbursements or an early payoff.
