MAY 9, 2024 PENN LAKE PARK BOROUGH COUNCIL MEETING

The Penn Lake Park Borough May Council meeting was held at the Penn Lake Park Community House. Council President Paul Rogan called the meeting to order at approximately 7:24 PM with the Pledge of Allegiance to the Flag followed by a statement that the meeting is streamed through the conferencing app., Gotomeeting, and is being recorded.

ROLL CALL: Mayor Tom Carter, Council President Paul Rogan, Council Members: Susan George, John Burden, Dan Eustice, and Corey Beltz.

PUBLIC COMMENT: None

MINUTES:

Minutes from the April Council Meeting were distributed to council members via email and posted on the Penn Lake Borough website. The copies will be recorded as the official minutes. A **Motion** to accept the April Council Meeting Minutes was made by Burden, 2nd by Beltz. Roll Call: Burden, Beltz, George, Eustice, and Rogan, all in favor, none opposed. Motion Carried.

TREASURERS REPORT:

The Treasurer's Report was presented. A **Motion** was made by Eustice, 2nd by George to accept the Treasurer's Report. Roll Call: Eustice, George, Beltz, Burden, and Rogan, all in favor, none opposed. Motion carried.

RECEIPTS/BILLS:

A **Motion** was made by Rogan, 2nd by George to pay the bills of \$36,787.62 and to accept the receipts of \$39,766.97. Roll Call: Rogan, George, Beltz, Eustice, and Burden, all in favor, none opposed. Motion carried.

PETITIONS OR COMPLAINTS: None

CORRESPONDENCE: Senator David Argall announced that he will host two Municipal Leader Funding Seminars on May 30th. The meetings will feature a presentation from the Senate Grants Team on funding opportunities for local municipalities. The first event will be held at the Faith Assembly of God Church at 34 Fox Manor Rd., Hazel Twp., at 8:30 AM. The second will be held at the Lansford American Legion, 3 W. Ridge St., Lansford, at 5:30 PM. Attendance must be confirmed by May 30th by emailing <u>shubler@pasen.gov</u> or calling 570-773-0891.

COMMITTEE REPORTS:

MAYOR – Carter – Reported the beaver seems to be gone although sightings have been reported. Carter was asked by a resident if toy motorboats are allowed on the lake, and Rogan replied "yes."

A **Motion** was made by Burden, 2nd by Eustice to accept Chris Zwiebel's resignation as Emergency Management Coordinator.

Roll Call: Burden, Eustice, George, Beltz, and Rogan, all in favor, none opposed. Motion Carried.

SOLICITOR – Keighlyn Oliver – Nothing to Report.

ZONING – 3 permits were issued: Add a structure at 1080 Lakeview Dr., a pavilion at 102 Hollenback Rd, add a structure at 1278 Lakeview Dr.

RECREATION- George – Nothing to Report.

LAKE MANAGEMENT - Eustice – Weekly water testing for both beaches will begin the week of May 19th. Water testing results will be posted on the Borough's website. Signs will be posted on the beaches in the event the E. coli levels exceed acceptable levels. Spraying will be contingent on the dam repair plan.

GOOSE ABATEMENT – Eustice – Geese numbers are down.

RTK/RECORDS –Burden – Nothing to Report.

ROADS –**Eustice** – The Borough received two bids for paving and pothole patching. Eustice spoke with Brian Strokes from AQUA who reported the Water Main Replacement project should be completed in June. AQUA will repair the damaged stormwater drain.

SEWERS – **Beltz** – 2 sewer permit applications were received. Seven Grinder pumps are still available.

SHORT TERM RENTALS- Burden – A hearing is scheduled for July 3 concerning a nuisance violation for garbage against Penn Lake Homes LLC.

DAM – Rogan – 5-9-2024 Meeting-Dam Report

- 4/19/2024 Received BRIC 2021 Penn Lake Park Borough Executed Grant Agreement. This is a necessary step before claiming part of the FEMA share of that grant in the amount of \$307,500.00.
- 4/21/2024 A few DAG members met to discuss how to motivate the DEP to act on our dam repair permit.
- 4/23/2024 Lisa Stuart brokered a meeting for August 8th with DEP Dam Safety in Harrisburg to discuss legal aspects of our permit application. The meeting will be attended by Rogan, George, and Stuart.
- 4/24/2024 Dan George met with Streamline and DEP to discuss the National Pollutant Discharge Elimination System (NPDES) Permit for Stormwater Discharges from Construction Activities. This is a necessary step for obtaining a dam repair permit.
- 5/2/2024 Rogan attended Dave Argall's Cinco de Mayo fundraising event. Some disappointing news was received at that event: Only \$100k of Penn Lake's requested \$2.6 million can be expected.
- 5/3/2024 A meeting with Federal Representative Matt Cartwrights office was arranged through personal connections to a borough resident. In the ensuing discussion, a Penn Lake onsite meeting is arranged with a representative from Cartwrights office, Dan George, Rogan, and Jim Brozeena.
- 5/8/2024 A face to face meeting was held with DAG members George, Stuart, Rogan, Dam Safety Director Kirk Kreider, a dam safety technical person, and 2 DEP attorneys attending remote. The purpose of the meeting was to understand how to get action on our seemingly stalled permit application, and to hear the results of the DEP legal review of our application held in February. A meeting is scheduled for 5/10 with attorney Dean to discuss some of the legal issues brought up by the DEP.

- 5/9/2024 Rogan reached out to people from Blytheburn Lake Association and Rice township/Ice Lake. The purpose was to understand and learn if they could provide information on how to motivate the DEP on our stalled permit application. Discussions with them will take place in the coming weeks.
- 5/9/2024 George, Rogan, and Jim Brozeena met with a person from US Senator Matt Cartwrights office at Rogan's home to discuss other funding opportunities. Sen Cartwrights office was encouraging, and we will report as we learn more.

AQUA Main Replacement Status - Covered in Roads under Committee Reports.

Grass Cutting Award – A Motion was made by Rogan, 2nd by George to award the grass cutting bid to Kislan for \$2500.00 plus \$35 per hour.

Roll Call: Rogan, George, Beltz, Eustice, and Burden, all in favor, none opposed. Motion Carried.

Patching and Paving Award – A Motion was made by Eustice, 2nd by Rogan, to award Shiffer Bituminous the paving and pothole patching bid for \$25,046.46.

Roll Call: Eustice, Rogan, Burden, George, and Beltz, all in favor, none opposed. Motion Carried. *2020 Drainage Upgrade Project* – A Motion was made by Rogan, 2nd by Beltz, to accept Borton Lawson's recommendation of Lehigh Asphalt Paving and Construction bid of \$57,232.00 for the Drainage Upgrade Project funded by the 2020 LSA Grant.

Roll Call: Rogan, Beltz, George, Eustice, and Burden, all in favor, none opposed. Motion Carried.

NEW BUSINESS:
